**ENROLLMENT INCENTIVES AND FEES**

- 1) Annual tuition must be received in full by July 30, 2010, or you will be set up on the installment payment plan.  
**If you pay in full, please subtract \$77 from the annual figure listed above.**
- 2) If you refer a new family who enrolls at Hillcrest Christian School, you will receive a \$250 credit toward your family's tuition. (The prospective student's parent must notify the school office of your referral.) It is our understanding that this credit is classified as income to you and is reportable to the IRS.

**FINANCIAL POLICIES**

If you choose not to attend Hillcrest, our refund policy states:

- a) Prior to July 1, one-half of the enrollment fee may be refunded if the request is in writing
- b) After July 1, no part of the enrollment fee is refundable

Tuition for the 2010-11 School Year is due and payable on or before July 30, 2010. In an effort to make tuition payments as convenient as possible, Hillcrest Christian School offers an eleven (11) month payment plan. For those using the monthly payment plan, there is an additional fee of \$77 per child. Please see the Hillcrest Christian School 2010-2011 Tuition Payment Information Form.

**FINANCIAL AID**

Hillcrest Christian School has established a tuition assistance fund for families who qualify. Application packets are available in the school office. Applications will be reviewed on a monthly basis. The student must be enrolled for the fall in order to receive an application for financial aid.

**PAST DUE ACCOUNTS**

A \$25 late fee will be charged if payment is not received by the 10th of the month. A tuition account which remains delinquent as of the last day of each month may result in suspension of the student(s) until the balance is paid. Special circumstances will be considered by the Business Office on an exception basis.

**RETURNED CHECKS**

To offset additional banking charges and processing expenses, a \$25 fee will be assessed on all returned checks.

**STUDENT WITHDRAWALS**

Tuition is an annual fee for the school year. However, if for any reason a student withdraws during the school year, charges will be prorated to the day of withdrawal. There is a \$25 withdrawal fee per student.
